New Millennium, a division of Steel Dynamics, Inc., announces the launch of new metal deck manufacturing operations in Hope, Arkansas. The expanded operations fulfill the company's goal to revitalize and grow the production of facilities acquired by the company here in 2010.

CORE BUSINESS

New Millennium Building Systems designs and manufactures steel joists, metal decking, castellated beams and other highly engineered, structural steel products for the non-residential construction markets.

PRODUCTS

New Millennium's structural steel products, available nationwide, include roll-formed and rod type standard steel joists, channel and rod type special profile steel joists, standard and specialty metal decking, and castellated beams. The company also provides engineered steel materials for the metal buildings market, nationwide.

SERVICES

New Millennium's capabilities include total-project cost reductions through early project design collaboration and proactive engineering. The company is also an experienced leader in BIM-based joist project design and process management. Related services include detailing, flexible manufacturing and delivery.

HISTORY

New Millennium Building Systems was founded in 1999 in Butler, Indiana. A second plant began production in 2005 in Lake City, Florida. A merger with John W. Hancock, Jr., LLC and Socar Inc. in 2006 has resulted in a dynamic team of people with deep industry experience. The former Hancock plant in Salem VA has undergone extensive renovations and equipment upgrades that have converted it into one of the most efficient joist production facilities in the country.

In September 2010, New Millennium's parent company, Steel Dynamics, Inc., announced the strategic acquisition of manufacturing and office facilities in the southwestern and western United States formerly owned by Commercial Metals Corporation (CMC). Three major facilities were acquired from CMC, which has exited from the steel joist and metal decking marketplace. These plants are located at Hope, Arkansas; Fallon, Nevada; and Juarez, Mexico. By investing in a range of efficiency and capacity upgrades for these acquisitions, New Millennium has become the second largest provider of steel joists and metal decking to the nationwide U.S. market
